RULES AND EXPECTATIONS

We expect our dog owners to be responsible pet owners. We have neighbors in 575 who are afraid of dogs so please be considerate. When you and your dog are waiting for the elevator in the lobby, please stand several feet away from the doors as they open. If others are waiting for the elevator, ask if it is okay to go in with your pet. If not, please allow them to go up first. Some of the requirements of 575 include, but are not limited to: keeping your dog on a short leash while in the building; cleaning up after your dog if it has an accident anywhere in the building; putting a muzzle on any dog that exhibits signs of aggression towards people or other pets; and grooming your dog properly if it sheds so that our superintendents and porters do not have to vacuum every time you enter and exit the building.

Your dog should have a name tag, an up-to-date rabies tag, and a NYS Dog License (required by law). We urge you to pick up after your dog outside.

▶ ▶ ▶ Please know that if a dog is brought onto the premises without proper approvals, the resident will be fined \$500 and legal action will be taken to remove the dog from the building. ◀ ◀ ◀

It is our sincere hope that these rules and expectations are followed so that no alternative measures are necessary.
